Financial Report by Celeste Lilley

- The Sequim WRF is back up to speed so we are hauling our sludge to them again.
- Jim Gross of BHC has gotten a response from WRL, the submersible aerator manufacturer. WRL will pay SWD \$12,000.00 for the two aerators and will pay shipping to get them back to their facility. BHC is requesting to be paid their full outstanding invoice balance. This is an action item that needs discussion.
- Ceccanti has been paid their full retainage.
- Mike Cays and Rich Sleeper are continuing to tweak the new additions to the treatment system to reach optimal performance.
- Chris Enges of Spirit Vision Films has provided a current aerial photo of the plant showing the new improvements.
- Troy Smith has harvested a crop of hay from the SWD spray field.
- Mike Cays, Rich Sleeper, and Andrew Cook attended a PNCWA meeting, training opportunity, and LOTT Wastewater Treatment Facility tour last week.

Water Meters/Meter Setters

- Gary and Andrew are installing water meters everywhere we have setters in place. We'll be back to installing setters as soon as possible.
- 650 meters have been installed to date!

Water Production/Consumption Results

- The total water pumped in 2014 was 84,754,836 gallons.
- The total water pumped in 2015 was 81,965,860 gallons.
- The static water level in the 250 foot well No. 1 averaged 80 feet for March while the pumping water level for that well averaged 92 feet for the same period.
- The static water level for the 129 foot well No.2 averaged **13 feet** for March while the pumping water level for that well averaged **23 feet** for the same period.

Other

- Charlie Smith of Lindberg Architects is working on our new office building plans and building permit application. I expect he'll have that ready for submittal next week.
- Mike Langley and Jay Griffith responded to a water leak on San Juan Drive the evening of April 26. After bailing out their water service and irrigation boxes, it proved to be associated with the irrigation system and Sanford Irrigation made repairs.
- Gary and Jay repaired a broken fire hydrant on Fairway Drive.
- I've purchased 100 additional water meters.
- The humidity control system at the upper reservoir has failed. I'm searching for a replacement. The manufacturer of the existing unit has gone out of business. I'm looking at units that are more energy efficient and quieter than the old unit.
- SWD personnel have been flushing water mains and exercising all isolation valves. This is an annual process.
- A security chain has been installed at the upper reservoir at SLOA's request.
