SERVICE CHARGES START AS FOLLOWS:

Billing for sewer service shall be rendered as follows for all customers:

All buildings, residences, or home sites constructed in SunLand, are subject to annual charges beginning the date of connection to the District's system. The date of connection will occur upon inspection by the District of the completed side sewer before backfilling. All services will be billed to the owner of the property.

As directed by the District Manager, the District will commence annual billing, with quarterly payments accepted. If billing is to begin other than the start of a new quarter, charges will be pro-rated as follows: If the connection occurs before the 15th of the month, the full applicable monthly charges shall be charged. If the connection occurs after the 15th of the month, one half of the applicable charge shall be charged.

Annual charges for water service will also commence upon connection to the sewer system and will be billed together with the sewer charge. (Note: The Application for Water Service and the Application for a Cross Connection Permit is submitted with the Application for a Side Sewer Permit and all applicable fees.)



APPLICATION FOR SIDE SEWER PERMIT

The undersigned hereby applies for permission to construct a side sewer as indicated on the preceding page.

The undersigned hereby agrees to construct a side sewer, as applied for above, subject to the following stipulations:

- 1. That all regulations and requirements set forth by the SunLand Water District, in accordance with WAC 246-272A-0025, be complied with fully and completely.
- 2. It shall be unlawful for any person to make any connection with any public or side sewer without complying with all of the provisions of this application in relation thereto and having first procured a permit to do so from the district.
- 3. Applicant and the Applicant's contractor agree to accept full responsibility and to indemnify and hold the SunLand Water District harmless, for any liability, damage and/or costs which may accrue from the prosecution of side sewer work under this permit.
- 4. The Owner hereby agrees to maintain the side sewer constructed under this permit in accordance with the rules and regulations of the SunLand Water District and, further, will permit access with entry by authorized representatives of the SunLand Water District on the property described in this permit at any reasonable time for the purpose of examination for compliance with all SunLand Water District regulations.
- 5. The Owner hereby agrees that any proposed modification of an existing accepted sewer connection to this property be pre-approved by the SunLand Water District.
- 6. The Owner is hereby notified that the SunLand Water District sewerage system is of the sanitary type system and agrees that he will not at any time connect storm water drainage from any source to the District's system. This includes, but is not limited to the following:
 - a. Roof Downspouts
 - b. Building Footing Drains
 - c. Springs on the Property
 - d. Any Outside Ground Water Drains



- 7. The Owner and his Contractor hereby agree to safeguard the work done under this permit in such a manner as to prevent injury and/or damage to the public. Such precautions shall include the employment of all necessary ditch safeguards such as lanterns, barricades, and safe access or egress through the working area. The Owner, and/or his Contractor, hereby agree to meet all applicable OSHA and WISHA regulations in the performance of this side sewer installation.
- 8. The Owner and/or his Agent agrees to employ a side sewer contractor, licensed by the State of Washington and covered by adequate and required satisfactory liability insurance, for all work to be prosecuted on public roads and rights-of-way. At the discretion of the District, the Owner may provide some or all of the required construction upon his property.
- 9. It shall be unlawful to make any connection to any public sewer, or to lay, repair, alter or connect any side sewer in any public area except by a side sewer contractor approved by the district.
- 10. The Owner and his Contractor agree to install the side sewer covered by this permit in full compliance with the District's side sewer requirements which include, but is not limited to the following:
 - a. A clean out shall be required at the point of connection with the side sewer stub.
 - b. Sewer pipe covers on private property to be at least 18 inches.
 - c. Minimum grade to be 2% unless special construction techniques are used per the Side Sewer Resolution 19.
 - d. No bends sharper than 45 degrees will be permitted without a clean out, and no group of bends totaling 90 degrees or more will be allowed without a clean out.
- 11. No backfilling will be allowed until the work has been reviewed and approved by the District's authorized representative. All backfill shall be tamped and/or water settled.
- 12. The Owner and his Contractor agree that all street cleanup and road restoration will be made to the satisfaction of the governing authority, i.e., City County, or State Highway, etc.
- 13. The Owner and Contractor agree to obtain at no cost or obligation to the District, all other necessary permits for construction work to be accomplished under this permit.
- 14. Upon final approval of this application, the district manager shall issue for district records an "asbuilt" drawing showing the size and location of the public sewer, the point of connection with the house or other building, the grade of such side sewer, and such other information as may be deemed pertinent.



- 15. The district manager shall prepare and keep on file all records of sewer connections showing the information obtained in the course of inspection of completed work done under such permit.
- 16. Upon approval of the application and issuance of the permit, it shall be unlawful to alter said permit or to perform any work other than is provided for in said permit.
